#### How does ISO work?

ISO is a framework that is to be implemented in order to maintain the smooth runing and efficiency of a business, especially in the case of growing companies such as Nankhoo & Hanslab. In these cases, having a sound Quality Management System (QMS) is a vital requirement in taking a Company to the next level.

#### THE FACTS...



- Obtaining the ISO 9001 certification through a certification body opens up international avenues for businesses.
- ISO 9001 specifies what a Company should do but it doesn't dictate
  how they should reach that goal. This allows flexibility and
  adjustment according to the particular business, the size, and the
  service or product rendered.
- The focus on continued improvement with emphasis placed on customer satisfaction will always lead to improvements in business performance.
- There are 8 sections of ISO 9001, namely:
  - Section 1: SCOPING
  - Section 2: NORMATIVE REFERENCE
  - Section 3: TERMS & DEFINITIONS QUALITY MANAGEMENT SYSTEM
  - Section 4: QUALITY MANAGEMENT SYSTEM
  - Section 5: MANAGEMENT RESPONSIBILITY
  - Section 6: RESOURCE MANAGEMENT
  - Section 7: PRODUCT REALIZATION
  - Section 8: MEASUREMENT ANALYSIS & IMPROVEMENT

## IMPLEMENTATION
